



Positive Change Donation Policy for Mississippi Market

Mission Statement:

Mississippi Market creates positive change in the community by influencing the production, distribution and enjoyment of food.

Positive Change Donation Policy:

One way we carry out our mission of *creating positive change in the community* is to support local nonprofit organizations through our Positive Change Program. Non-profit organizations with missions dedicated to the environment, sustainable agriculture, and food access are eligible to apply.

This program enables shoppers to round up their purchases or donate 10¢ credits when they bring their own reusable bags to shop. Positive Change recipients collect donations for a one month period from all three stores and are publicized throughout our stores and website. Donations are generally granted to organizations at most once every two fiscal years (July-June).

When considering a potential Positive Change recipient, we look at the following criteria:

1. Does the organization mission pertain to local & sustainable agriculture, local hunger initiatives, nutrition education, or environmental sustainability?
2. Is the organization within St. Paul or the surrounding community?
3. When has the organization last received a donation from Mississippi Market?

We recognize there are many causes worthy of our support, but we feel that focusing our resources to a few select areas that relate to our mission has more impact.

Positive Change applications are accepted on a rolling basis throughout the year with quarterly review dates:

Submission Deadline	Donation Recipient Months
May 31	Aug-Sept-Oct
August 31	Nov-Dec-Jan
November 30	Feb-March-April
January 31	May-June-July

Positive Change recipients will be notified 30-60 days in advance of their Positive Change month start. At Mississippi Market Natural Food Co-op's discretion, the Positive Change recipient calendar may be preempted to raise emergency or disaster relief funds.
